If the manuscript is submitted through the platform, this document must be uploaded as a complementary file. If the submission is made to the Journal's e-mail address (<u>revista.inie@ucr.ac.cr</u>), it is sent together with the manuscript.

Requirements for sending the Letter:

This document, duly completed, must be sent digitally by e-mail, scanned in PDF format, addressed to the editor Mag. Rebeca Vargas Bolaños, Instituto de Investigación en Educación, Universidad de Costa Rica, Sede Universitaria Rodrigo Facio.

If the letter does not comply with these guidelines and/or is not sent together with the manuscript, the application will be invalid and will not be considered for the evaluation, editing and publication process.

To this process, the document or identity card of each author of the manuscript must be attached, to validate the signature of those involved. In digital format, scanned.
